LAST WILL AND TESTAMENT OF MYRON WYN EVANS

This is the last Will and Testament of me, Myron Wyn Evans, of 50 Rhyddwen Road, Craig Cefn Parc, Swansea, SA6 5RA, Wales, made in respect of my real and personal estate situate in England and Wales. I revoke all former wills, codicils and testamentary dispositions.

A) As executors and trustees of this Will I appoint the present Trustees of the Newlands Family Trust.

- B) The expression "My Trustees" shall mean the trustees for the time being of this my Will, or (as the context requires) my personal representatives for the time being.
- C) Any power given to the Trustees of this Will (by the Will or any Codicil to it under the general law) may be exercised by my Trustees before the administration of my Estate is complete and even before a grant of representation has been obtained.
- 1) The Newlands Family Trust shall come into operation after I am deceased by transfer of my Estate into the Trust. The Trustees have already been appointed and are, at present:
- a) Peter Lynn and Partners, Trust Solicitors.
- b) My wife Larisa and myself.
- c) Dr Gareth John Evans.
- d) Mr Ashley Jones.
- The Newlands Family Trust shall own this house, 50 Rhyddwen Road, Craig Cefn Parc, Swansea, SA6 5RA, and shall rent it to a responsible and able Welsh speaking caretaker free of rent. The caretaker shall pay all running costs and conserve the interior and exterior of the house, and the grounds, in good order. The caretaker shall pay any Trust taxation on the Newlands Family Trust which may accrue due to the increase in value of the house and land. The contents of the house shall be maintained in good order so that it is a memorial of my work. The caretaker must be a strong supporter of the Welsh language and active on its behalf.
- 4) If I predecease her, the current pensions of my wife Larisa, and any pensions derived from my pensions, shall be augmented from the Trust Capital, bearing in mind the main purposes as described as follows, notably the need to conserve capital for investment. She shall be looked after financially by the Trustees. A schedule of investments is kept by Peter Lynn and Partners. Most of the investments are currently tax free vehicles. If my wife Larisa wishes to reside abroad in her apartment then the caretaker can be appointed immediately I am deceased. If my wife Larisa wishes to reside at 50 Rhyddwen Road the Trustees will allow her to do that for as long as she wishes or until she is deceased. The caretaker will be appointed as soon as possible thereafter. The Trustees shall have the power to evict the caretaker if there is a breach of contract of tenancy. The contract of tenancy shall be signed by the Trustees and caretaker.
- The original papers of ECE theory and my collected papers shall be bequested to The National Library of Wales, and made available to scholars and students, and members of the general public. They are currently kept in A4 Folders and Box Folders in the library of 50 Rhyddwen Road. If the National Library of Wales cannot house them, then the Trustees shall find a suitable home for the papers. If a suitable home for the papers cannot be found, then the caretaker of 50 Rhyddwen

Road shall conserve them diligently and carefully. A suitable home could be any other library in Wales, a legal deposit library such as the British Library in London, or any reputable university library in the world.

- As much as possible of the Trust Capital shall be invested by the Trustees for the entire lifetime of the Trust, in the first instance 125 years. After some years the capital will have accumulated to many millions, possibly hundreds of millions, of pounds, all of which shall be used wisely and diligently for the benefit of the Welsh language by the then Board of Trustees. The major beneficiary would be Eisteddfod Genedlaethol Cymru, The National Eisteddfod of Wales, which would distribute the funds as it sees fit. The Trustees shall strive to minimize taxation by establishing The Myron Evans Charitable Trust immediately I am deceased, using the fluid capital of my Estate. Taxation on a charitable trust is much less than taxation on a family trust, and the Myron Evans Charitable Trust's aims are cultural, linguistic, conservational, environmental and similar. So it would qualify to be registered as a Charitable Trust. The buildings of 50 Rhyddwen Road and the grounds shall remain within the Newlands Family Trust and shall never be sold. The purpose of this is to help ensure the survival of the Welsh language. Property on the open market is almost always bought by people who have little interest in the language and this quickly leads to the extinction of the spoken language, a breach of human rights which is allowed to occur at present.
- The Trustees of the Myron Evans Charitable Trust shall use some of the accumulated capital of millions to hundreds of millions of pounds to purchase 48
 Rhyddwen Road and merge it with 50 Rhyddwen Road as originally intended by my great grandfather, William Newlands. Number 48
 Rhyddwen Road shall be put back into its original 1897 condition and conserved. The two houses shall be named "Ty^ Bryn Awel", owned by the Trust and occupied by the caretaker of paragraph (2). Some of the accumulated capital shall be used to protect Elim Baptist
 Chapel, Craig Cefn Parc, to refurbish the organ and maintain it. If necessary the chapel shall be purchased by the Trust and rigorously conserved and revived. I wish to be buried in the grounds of the chapel. If that is not possible for some reason I wish to be buried in a private chapel constructed in the grounds of 50 Rhyddwen Road. If necessary the Trustees would purchase and conserve Elim, and other historical chapels in Mawr.
- of millions to hundreds of millions of pounds to regularly fund the AIAS / UPITEC (www.aias.us and www.upitec.org) for the purposes of applying ECE theory to scientific research and discovery. If necessary, some of the capital shall be used to conserve the websites www.aias.us and www.upitec.org. under secure conditions in several copies at different localities

Whoever benefits from the Trust after my days shall be under a duty to diligently maintain and protect the Trust Fund and all this comprises. I acknowledge that there is a Perpetuity constraint relating to a Family Trust, in first instance 125 years, but at the end of that time the Trust shall be renewed by the Board of

Trustees and capital accumulation continued for another 125 years. The Trust shall not come into existence until I am deceased, and this Trust Deed shall be interpreted as my last Will and Testimony, being in sound mind and body, and shall replace all previous Wills. There is no Perpetuity constraint on a Charitable Trust, and very little taxation. This would allow the liquid capital to accumulate until the Trustees of the Charitable Trust can begin to disperse the capital to all kinds of good causes relating to the Welsh language. It would operate in the manner for example of the Nuffield Foundation, Wolfson Trust and similar, and would need high quality and dedicated Trustees all of whom would be Welsh speaking in the manner for example of Chapel Trusts
